Welcoming Aidan's appointment as interim CEO and Executive Director, Paschal Taggart said: "I am pleased that Aidan has agreed to act as interim CEO pending the appointment of a permanent candidate to the role. Aidan has been a key member of the executive team for the last 16 years and has played a central role in our achievements to date. The board believes he is well equipped to lead Datalex during this transition, and that we will continue to grow the business and increase shareholder value. The business is performing in line with guidance to date in 2012, and the board looks forward to the remainder of the year with confidence".

He is a leading strategist in travel distribution, and with nearly 20 years experience in the airline and travel industry, he has been instrumental in building our leading product and market positions. Prior to joining Datalex, Aidan held a number of positions with Westinghouse in its airline and travel business in the Middle East.
