(“CGII”), which in turn is the parent company of five investment management companies (“CGII management companies”): Capital Guardian Trust Company, Capital International, Inc., Capital International Limited, Capital International Sàrl and Capital International K.K. The CGII management companies primarily serve as investment managers to institutional clients.

Neither CGC nor any of its affiliates own shares of your company for its own account. Rather, the shares reported on this Notification are owned by accounts under the discretionary investment management of one or more of the investment management companies described above.

SMALLCAP World Fund, Inc. (“SCWF”) is a mutual fund registered in the United States under the Investment Company Act of 1940. SCWF is the legal owner of 3,092,000 shares (4.0505% of outstanding shares).

SCWF has granted proxy voting authority to CRMC, its investment adviser.
