This is a correction of a previous notification submitted to the issuer on 19 December 2019, which erroneously stated that the total number of voting rights of the issuer was 78,099,842 rather than 81,983,842. Accordingly, the total position of the person(s) subject to the notification obligation should have been stated as 4.84% (rather than 5.08%) and therefore the 5% threshold was also crossed.
